#### **Drug Facts:**

Active Ingredient (in each 0.8 mL): Acetaminophen 80 mg Purpose: Pain Reliever/Fever Reducer

#### Uses

Temporarily reduces fever.

Temporarily relieves minor aches and pains due to: • Flu

- Common Cold
- Headache
- Toothache
- Sore Throat

#### Warnings

Sore Throat Warning: If sore throat is severe, persists more than 2 days, and is accompanied or followed by fever, rash, nausea, headache or vomiting, consult a doctor immediately.

Do not use with any other product containing acetaminophen.

#### **Overdose Warning**

Do not exceed recommended dose; taking more than the recommended dose (overdose) may not provide more relief and may cause liver damage. In case of overdose, get medical help or contact a Poison Control Center (1-800-222-1222) immediately. Quick medical attention is critical even if you do not notice any signs or symptoms.

#### Stop Use and Ask a Physician if:

- New symptoms occur
- · Redness or swelling is present

• Pain gets worse or lasts for more than 5 days

• Fever gets worse or lasts for more than 3 days These could be signs of a serious condition.

#### Keep out of reach of children.

#### Directions

- Do not take more than directed (please see warnings)
- · Shake well before using
- Find dose on chart below (if possible, use weight to dose; otherwise use age)
- Dispense liquid slowly into child's mouth, toward the inner cheek
- Repeat dose every 4 hours, if needed
- · Do not use more than 5 times in 24 hours

#### **Dosage and Administration**

It is very important that Pediaphen Concentrated Drops be dosed accurately. It is strongly recommended that caregivers obtain and use a calibrated measuring device. Healthcare providers should recommend a dropper that can measure and deliver the prescribed dose accurately, and instruct caregivers to use extreme caution in measuring the dosage.

24-35 lbs.	2-3 yrs.	1.6 mL

#### **Inactive Ingredients**

acesulfame K, citric acid, corn syrup, FD&C Red No. 40, flavoring, glycerin, polysorbate 80, purified water, sodium benzoate, sorbitol solution, sucralose, veegum and xanthan gum.

#### Other Information

- Keep tightly closed.
- Store at controlled room temperature, 20° - 25° C (68° - 77° F). [See USP].
- Protect from freezing.
